

FEE-FIXING RESOLUTION - 2023

AGONA EAST DISTRICT ASSEMBLY

LOCAL GOVERNANCE ACT, 2016 (ACT 936) SECTION 94

(1ST JANUARY TO 31ST DECEMBER, 2023)

It is hereby resolved and approved by the Agona East District Assembly in accordance with section 34,76,77, 78 and 94 of the Local Governance Act,2016 (Act 936), that the following rates, fees be charged by the Agona East District Assembly for the Financial Year 1st January to 31st December, 2023.

It shall be the duty of every person due to pay these rates, Fees and Licences or part thereof to do so in the case of annual fees on or before 31st March, 2023. In the case of monthly fees on or before the 10th day of the month and in the case of daily fees, before 2.00 p.m. each day.

Payment in all cases should be made at any Revenue Collection Office of the Agona East District Assembly or the respective Revenue Collector or any other authorized rate collector.

PENALTIES

1. Any person who without any lawful justification or excuse, the proof which lies on him/her, refuses or wilfully neglect to pay any, licences, charges payable by him/her on or before the stipulated date shall pay a penalty of **GH C 50.00** for Basic Rate and **GH C 500.00** for other Rates, Fees and Licenses. This is without prejudice of any action the court might impose together with the amount defaulted.

Any person who makes false statements with regards to his/her liability shall pay a penalty of not less than **GH C 300.00** and not more than **GH C 500.00** . Any person who assist or incites a person to make false statement or refuse payment of his liability to pay Rate/ Fees/ Licenses shall be guilty of an offense as the person who makes false statements shall attract the same penalty of not less **GH C 300.00** and not more than **GH C 500.00**. This is without prejudice of any action the court might impose together with the amount defaulted.

2. Any person, not been authorised by Agona East District Assembly collect or attempt to collect Rate/Fee/Licenses shall pay a penalty of **GH C 2,000.00**. This is without prejudice of any action the court might impose together with the amount defaulted.
3. Agona East District Assembly shall constitute a task force at any time to embark on revenue mobilization campaign. The task force shall have the power to lockup stores and premises of recalcitrant Rate payers and put them before court.
4. Any person who wilfully obstruct a Revenue collector, task force member or accredited agent of the Agona East District Assembly to perform his/her legitimate duty shall pay a penalty of **GH C 1,000.00** and refund of medical bills and the cost of material destroy. This is without prejudice any action there might impose on him/her by the court.
5. Any person who fails to pay these Rate, Fees, Permits, levies and other charges before the 1st of April, 2023, is liable for prosecution by the Agona East District Assembly or any action of its authorised agents.
